- 1) All teams participating in the tournament will be USA Softball registered.
- 2) All umpires working the tournament will be USA Softball registered.
- 3) The tournament director will collect travel permits from out-of-state teams.
- 4) For Junior Olympic Youth Tournaments the fee is \$10.00 per age division.
- 5) Invitational Tournaments may establish rules and regulations for their tournament, provided such rules and regulations are not in conflict with the USA Softball Code. Joint ventures with competing organizations are prohibited without the expressed written consent of the District Commissioner.
- 6) No invitational tournament may be conducted which conflicts with state championship play for that division of play.
- 7) Junior Olympic (Youth). The sale or possession of beverages that contain alcohol on the softball complex is prohibited.
- 8) A copy of the tournament invitation and tournament bracket must be sent to USA Softball of Texas District 14 Commissioner.
- 9) No player or coach disbarred or suspended by USA Softball is eligible to enter the tournament or be listed on a team roster.
- 10) Failure to comply with the above teams may result in this tournament being place under suspension. In addition, USA Softball may suspend individuals responsible for this tournament if it is found that the tournament is in violation of the USA Softball Code.
